Report to Synod Belhar 2021 from Deputies Theological Training (Deputies Curators)

Amendments to Report of Deputies Curators with regard to budget deficits and references to funding from MDSA, Mission Board and ZAM

Background

In the Deputies Curators' (DC) Report financial deficits of DC are discussed with reference to funding by MDSA, Mission Board and ZAM, under several headings. MDSA representatives discussed these parts of the Report with DC on 16 March 2021 and highlighted incorrectness or incompleteness of information as follows:

- In early 2017 the need for assistance from Rev Breytenbach [in the mission field] was
 discussed during a number of meetings with all stakeholders. It was agreed that Rev
 Breytenbach's mission support would be managed and funded by the Mission Committee
 (formerly Mission Board) of FRC Pretoria-Maranata. It was agreed that Rev Breytenbach
 would be paid on a contract basis for the mission related work, as per time spent on
 mission-related work. Payment would come from the church council of Pretoria-Maranata,
 with funds from MDSA/ZAM.
- 2. As from 1 June 2017 Maranata's Mission Committee allocated projects to Rev Breytenbach in its Strategic Mission Plan, and determined time allocation per project. The accumulated time was then planned as a percentage of Rev Breytenbach's total time (100%). As the Mission Committee's need for Rev Breytenbach's services subsequently decreased, his involvement in the mission field decreased from a planned 40% to 0% in 2020. This decrease was planned by church council of Pretoria-Maranata in its Strategic Mission plans and budgets (annual and 5 year budgets).
- 3. The statement made in the Curators' report that the reduction in MDSA contribution from 40% to 0% was due to less money being available from the Netherlands (ZAM) was never given as a reason by MDSA. MDSA was informed in October 2017 by ZAM about the change in policy i.e. 4 months after the new agreement on Rev. Breytenbach's involvement in mission work was reached.

Amendments to the DC Report

Based on the discussion of 16 March 2021 DC submit the following Amendments to their Report with apologies to MDSA and ZAM.
